### HOUSING SCHEMES IN URBAN AREAS

#### NO. 70. SHRI A. A. RAHIM:

# Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) the number of people who do not have houses in urban areas, State-wise;
- (b) the number out of this which belong to the SC and ST communities, respectively;
- (c) the number of them that belong to the Christian and Muslim communities and the number of them belonging to economically backward among forward castes;
- (d) the States which are implementing housing schemes with the inclusion of PMAY and the contribution of States in these projects; and
- (e) whether PMAY is directed to be branded in these schemes and whether there is any direction to cut the central allocation for projects that do not do so?

## **ANSWER**

# THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a) to (c) As per Census 2011, State/Union Territory (UT)-wise details of urban houseless population and houseless population under Scheduled Caste (SC) and Scheduled Tribe (ST) categories in urban areas are given at Annexure.
- (d) & (e) 'Land' and 'Colonization' are State subjects. Schemes related to housing for urban poor in their respective areas are implemented by States/UTs. However, the Ministry of Housing and Urban Affairs is supplementing the efforts of States/UTs by providing Central Assistance under Pradhan Mantri Awas Yojana- Urban (PMAY-U) 'Housing for All' Mission since 25.06.2015 to provide pucca houses with basic amenities to all eligible urban beneficiaries across the country.

The scheme has four verticals namely, Beneficiary-led individual house construction/enhancements (BLC), Affordable Housing in Partnership (AHP), "In-Situ" Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS).

Identification of eligible beneficiaries and implementation of projects under PMAY-U is the responsibilities of State/UT Governments concerned. All State/UT Governments prepare project proposals as per demand in consonance with scheme guidelines of PMAY-U. The project proposals are approved by the State Level Sanctioning and Monitoring Committee (SLSMC) of respective States/UTs before consideration by Central Sanctioning & Monitoring Committee (CSMC) for sanctioning Central assistance.

Government of India is providing its fixed share as Central Assistance of ₹1.0 lakh per house under ISSR, ₹1.5 lakh per house for AHP and BLC verticals of PMAY-U. Under CLSS vertical of PMAY-U, an interest subsidy at the rate of 6.5% which amounts upto ₹ 2.67 lakh per house was provided for beneficiaries of Economically Weaker Sections (EWS) and Lower Income Group (LIG) category. Apart from the Central Assistance, the remaining cost of the house as per the Detailed Project Report (DPR) is shared by States/UTs/Urban Local Bodies (ULB)/Beneficiaries. This Ministry has not prescribed any fixed amount of contribution by the State/UT Governments. PMAY-U guidelines promote convergence with other State schemes.

As per the scheme guidelines, it is mandatory for all States/UTs to ensure display of PMAY-U logo and beneficiary details on all houses constructed under the scheme and instructions have been issued from time-to time to States/UTs, to ensure compliance of the same.
