Honorarium of school cooking staff

1152 Shri A. A. Rahim:

Will the Minister of *Education* be pleased to state:

- (a) the quantum of honorarium for school cooking staff as per Union Government norms;
- (b) the details of Union Government and State Government share in this;
- (c) whether there are States that pay more than the amount determined by the Union Government, if so, the details thereof; and
- (d) when were the existing norms issued, whether the Union Government has any plan to renew it, if so, the details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

(a) to (d): Under PM POSHAN Scheme, the Cook-Cum-Helpers (CCHs) are engaged for preparing and serving hot cooked meals at schools. They are honorary workers who have come forward for rendering social services. As per guidelines of the Scheme, Cook-cum Helpers (CCHs) are paid uniform honorarium of Rs.1000 per month for 10 months in a year, with effect from 01.12.2009 in recognition of their services. However, other norms like Transportation assistance, Management Monitoring and Evaluation (MME), Central Assistance for Kitchen Devices, Assistance for repairing of Kitchen-cum-stores etc were revised in 2019. In addition, the material cost was also revised on the basis of the Consumer Price Index (CPI) by increasing 9.6% over and above the existing material cost in 2022.

The honorarium expenditure is shared between the Central Government and States and UTs as per the approved sharing pattern of 90:10 for North Eastern Region (NER) States, 2 Himalayan States (Uttarakhand and Himachal Pradesh) and UT of J&K, 100% for Union Territories without Legislature and 60:40 for other States as well as 2 Union Territories with Legislature (Delhi and Puducherry). The State Governments and UT Administrations also supplement the honorarium by providing additional funds from their own resources. State and UT-wise details of honorarium paid to CCHs are given at Annexure.
